<b>Explanations</b>	

With the material event disclosures of our Company dated 16.01.2026 and 14.02.2026, it was publicly announced that, within the scope of the tender for the procurement of 4x4 Tactical Wheeled Light Armored Vehicles, which was initiated by the Romanian Ministry of National Defence through C.N. Romtehnica S.A. (Romtehnica) and awarded to our Company, Romtehnica submitted payment claims to our Company in the amounts of 191,847,899 Romanian Lei and 230,217,479 Romanian Lei, respectively, alleging that the interim milestones regarding the local production preparations under the contract schedule for the portion to be produced in Romania were not fulfilled on time.

It was also publicly announced that the first of these payment claims was paid on its due date without prejudice to our legal rights, that an annulment lawsuit was filed regarding the relevant claim, and that the second claim was planned to be paid on its due date within the first quarter of 2026, without prejudice to our legal rights, and that an annulment lawsuit would also be filed regarding this claim.

At the current stage, an annulment lawsuit was filed against the second claim together with a request for suspension of enforcement .In the lawsuit filed in relation to the second claim, the Romanian courts have ruled that the annulment lawsuits filed by our Company shall be heard jointly, and further decided, subject to the right of appeal by the opposite parties, to suspend the enforcement of the second payment claim amounting to 230,217,479 Romanian Lei until the court decision becomes final.

Accordingly, our Company's second payment obligation amounting to 230,217,479 Romanian Lei is presently suspended, and further developments regarding the litigation process will be shared with our investors through material event disclosures and/or our activity reports, depending on the significance of the matter.

This statement has been translated into English and simultaneously announced for informational purposes. In the event of any discrepancy between the Turkish and the English versions, the Turkish version shall prevail.
