Otokar sales amounted to 5.123 million TL, 92% higher than last year. (2021 9M 2.675 million TL)

Export revenues amounted to 3.221 million TL (2021 9M 1.804 million TL)

The share of exports in total turnover in the first nine months of 2022 realized as 63% (2021 9M 67%)




As a result of the first nine months of 2022 financial results, our Company's net profit realized 601 million TL net profit (2021 9M 516 million TL net profit).
