Within the scope of the issuance limit approved by the Capital Markets Board's decision dated 19.01.2023 and numbered 3/62, our Company must pay coupons at a fixed interest rate of 41.5% every 3 months, with a maturity of 752 days, to be sold to qualified investors without public offering, 30.06.2025. As a result of the bookbuilding process carried out for the bond with the redemption date and ISIN code of TRSOTKR62516, the total issuance amount was finalized as 500.000.000 TL and the sale transaction was completed on 08.06.2023. Settlement will be completed on 09.06.2023. The issuance was managed by Garanti Yatırım Menkul Kıymetler A.Ş.. This statement has been translated into English for informational purposes. In case of a discrepancy between the Turkish and the English versions of this disclosure statement, the Turkish version shall prevail.
