PRIVACY NOTICE ON PROCESSING OF PERSONAL DATA REGARDING THE DATA BREACH
NOTIFICATION and COMMUNICATION PROCESS

1) Data Controller

The protection of your personal data is held at utmost importance by Otokar Otomotiv ve Savunma Sanayi A.Ş. ("**Company**") who acts as a data controller in accordance with the Personal Data Protection Law No. 6698 ("**Law**").

You may find detailed information regarding the processing of your personal data on Otokar Otomotiv ve Savunma Sanayi A.Ş. 2) Purposes for Processing Personal Data

Your personal data may be processed by our Company for the purposes of carry out the necessary processes within the scope of receiving, evaluating and finalizing requests, complaints and suggestions from the relevant persons who benefit the products and services offered by our Company, evaluate and inspect the necessary processes to be managed by our Company regarding the notification you provide to us with respect to potential data breaches occurred within our Company ("**Purposes**"), in accordance with the data processing conditions and purposes set out in Articles 5 and 6 of the Law.

3) Recipient Parties and Purposes for Transferring Personal Data

Your collected personal data may be transferred for above-mentioned Purposes to legally authorized public authorities, and legally authorized private institutions, if explicitly stated in the laws or for performing our legal obligations pursuant to the data processing conditions set out in Articles 5 and 6 of the Law and in relation with the rules on transferring personal data specified in Article 8 of the Law.

4) Method of and Legal Ground for the Collection of Personal Data

Your personal data is collected and processed by our Company for receiving, evaluating and managing the necessary inspection processes regarding your requests, complaints and suggestions for the products and services offered by our Company and data breach notifications electronically through our Company's web page, telephone, e-mail, fax and social media channels, depending on the legal grounds of the Company's legitimate interest and legal obligations, in accordance with the data processing conditions set out on Articles 5 and 6 of the Law.

5) Data Subject's Rights Specified under Article 11 of the Law

We hereby declare that in relation to your personal data, you are entitled to the following rights, set forth under Article 11 of the Law:

- To learn whether your personal data are being processed,
- To request information if your personal data have been processed,
- To learn the purpose of the processing of your personal data and whether they have been used accordingly,
- To learn which third parties domestic or abroad your personal data has been transferred to,

- To request rectification in case your personal data has been processed incompletely or inaccurately and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- To demand the erasure or destruction of your personal data in the event that the reasons for the processing no longer exist even though it was processed in accordance with the Law and other relevant provisions and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- To object to negative consequences to you that are concluded, as a result of analysis of the processed personal data through solely automatic systems,
- To demand compensation for the damages that you have suffered as a result of an unlawful processing of your personal data.

You may convey your requests concerning your rights listed above to our Company, by filling out the Otokar Otomotiv ve Savunma Sanayi A.Ş. Depending on the nature of your request, your application will be concluded by our Company, as soon as possible, within 30 days at the latest and in principle, free of charge. However, if the process requires additional costs, a fee may be demanded by our Company according to the tariff determined by the Personal Data Protection Board.
